*A \$1,000.00 Nonrefundable deposit is required in order to guarantee your spot. The remainder is due 45 days prior to the start date of your hunt. Cancellation refunds can only be made if a substitute hunter fills your spot and contracts the hunt. The deposit can, under certain circumstances and by agreement of both parties, be transferred from one party to another or to a future hunt or service.*

**Licensing:** *The hunter is responsible for all State licensing fees and State sales tax. All hunts are conducted in strict compliance within the laws and regulations of the State of New Mexico. You will be accompanied by a NM licensed guide for a minimum of two (2) full days during your hunt if you draw a tag using the 10% guided draw pool.*

**Equipment:** *The hunter shall provide personal transportation to hunting headquarters, unless other arrangements have been agreed to by all parties. Hunter is responsible for a weapon, ammunition and all personal articles (Hunters Checklist is available). Outfitter shall provide meals, lodging and guide service, field dressing of game, and packing to hunting headquarters.*

**Hunters Responsibility:** *The hunter is solely responsible for his/her physical condition. Hunts take place in rough terrain in high altitudes! If hunter has any doubts about his/her ability to withstand strenuous activity at high altitudes, he should consult his doctor. The hunter represents that he/she is an experienced hunter and is responsible for any and all hunting hazards.*
